Distinction of work between employer and employee

Our activities take place exclusively at the request of the employer and this contract is therefore one between Klap b.v. and the employer. The category of work consists only of information to the employees and does not include advice. All our activities are carried out under and within the scope of our Pension Financial Supervision Actpermit.

Fee for our services

As a pension adviser, we believe it is important to provide you in advance with an understanding of the costs involved in our work, in a transparent manner. All the work we do to provide advice on the pension plan and its creation takes place on the basis of a fee that we charge directly to you, i.e. we are not remunerated by commission or otherwise by insurers.
